RELEASE AND WAIVER OF LIABILITY

(This document affects your legal rights. You must read and understand it before signing it)

I acknowledge that all activities and conduct relative to Off-Highway Vehicles, including All-Terrain Vehicles ("ATVs"), are inherently dangerous activities with the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, natural plant and animal life, facilities, temperature, weather, equipment, vehicles, traffic, remote location, actions of other people (including, but not limited to, participants, volunteers, spectators, Trail Bosses, club officers, guides and/or government agency officials), lack of nutrition, lack of hydration and failure to use ATV riding gear and apparel, including, but not limited to, a helmet, eye protection, chest protector and boots. These risks are not only inherent to participants but are also present for volunteers and spectators, and I assume all of the risks of participating in and/or volunteering for such activities and events. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, provided or controlled by them or because of their possible liability without fault.

In consideration of my Membership and permitting me to participate in activities and events sponsored or in any way connected with Dirty SOBS Inc., (Dirty SOBS) I hereby take action for myself, my executors, administrators, heirs, representatives, next of kin, successors and assigns as follows:

- A. Acknowledge that my participation in any DIRTY SOBS related activity is purely voluntary and no one is forcing me to participate in spite of the risks;
- B. Acknowledge that I am solely responsible for determining, among other things, what equipment, supplies, vehicle and apparel I utilize while participating in any DIRTY SOBS related activity;
- C. Acknowledge that my participation in any ATV activity connected with DIRTY SOBS does not relieve me from obeying the laws of the land, including but not limited to, lands controlled by the Bureau of Land Management, State Trust Land, National Forest Service, Border Patrol, local sheriff's departments or public law enforcement officers;
- D. WAIVE, RELEASE, AND DISCHARGE FOREVER FROM ANY AND ALL LIABILITY for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me, DIRTY SOBS, its agents, employees, managers, officers, Trail Bosses, directors, chair persons, instructors, volunteers, members, successors and assigns (collectively "Releasees"); and
- E. WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees from any and all rights, suits, actions, judgments, damages or costs, and claims, including claims arising from the Releasees' own negligence (except for claims arising as a result of Releasees gross negligence or willful misconduct), that may result by reason of any and all damages which may be sustained by me, or by others as a result of my actions, directly or indirectly, in connection with or arising out of my participation in or association with an DIRTY SOBS activity or event.

I hereby consent to receive medical treatment, which may be deemed advisable in the event of injury, accident and/or illness during an DIRTY SOBS activity or event. I am aware that DIRTY SOBS does not carry insurance, and I am responsible for my own insurance protection. I understand that while participating in any DIRTY SOBS activity or event I may be photographed, and I agree to allow my photo, video or film likeness to be used for any legitimate purpose by DIRTY SOBS and/or the photographer. This Release and Waiver of Liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
